
NOW THEREFORE THIS DEED OF AMENDMENT TO THE TRUST DEED WITNESSES AS FOLLOWS:

“1. To substitute the words and quotations “Little Flower Educational and Charitable Trust “in clause 1 with words and quotations “St. Therese English Medium School”

2. To substitute the words Little Flower Educational and Charitable Trust in clause 3 under the name clause with words “St. Therese English Medium School”

3. To substitute the existing clause 6 (i) under the object clause with “6 (i) To establish and manage educational institutions of excellence in the general, technical and professional sphere and to impart such education to people at large irrespective of religion, caste, creed or colour without any profit motive.”

4. To substitute the existing clause 6 (iv) under the object clause with “6 (iv) All educational institutions established and administered by the St. Therese English Medium School are minority institutions covered under Article 30 (1) of the Constitution of India.”

5. To substitute the figures and letters 1/3rd in sub clause 2 in clause 8 Meeting of the Board of Trustees with figures and letters “2/3rd”.

It is therefore become necessary to change the trust deed with the substitutions/ amendment described as above.

Apart from the above said provisions and the amendments as per document No. 54 of 2013 and as per document No. 14 of 2015, there is no addition or amendment to the said principal trust deed but is meant
